## Footnotes:

**Scope of emissions** - scope of emissions included is scope 1, scope 2 and limited scope 3 (categories 3, 5 and 6 only)

**Normalisation** - Well-to-tank (Scope 3 – categories 3 and 6) and radiative forcing associated with air travel (Scope 3 – category 6) have been normalised for relevant emission sources as these were not previously included in certification. In addition, hotel emissions have been normalised because it has been measured for the first time.

**Electricity** - scope 2 electricity emissions are reported in two ways: location-based and market-based methods. Location-based electricity emissions have been calculated using carbon emission factors for average national grid electricity. Market-based electricity emissions have been calculated using emission factors for Eden Project's electricity supply directly from the renewable electricity supplier.
